CONDITIONS OF USE OF THE SERVICE FREE PLAN CONFERENCE CALL

These Conditions of Use govern the provision of the Service by Consulting Smartic Solutions, SL established in P^o de la Castellana, 135, 7^a, 28046 Madrid (Spain), and CIF/VAT B85130037 (hereinafter SMARTIC) to the user (hereinafter CUSTOMER) who uses this free plan conference call SERVICE in accordance with the below conditions

DEFINITION OF SERVICE AND CONDITIONS OF ACCESS

The "Free plan service" is a free conference call service that allows up to six participants to communicate simultaneously in Spain (hereinafter "SERVICE") The CUSTOMER shall be equipped with at least one fixed telephone or mobile terminal in Spain from which they dial the identification number (code) and PIN previously assigned by SMARTIC that allows use of the SERVICE trhough a 902 number. The CUSTOMER shall provide all participants of the conference call: the 902 phone number which will direct the calls to the conference room in Spain, the identification code, and time/date agreed upon time for the conference call.

To enter, simply call the 902 number from any landline or mobile within Spain and dial the identification code. The use of the SERVICE as stated above will assume the express acceptance of these Terms of Use from the first time the SERVICE is accessed. The CUSTOMER agrees to keep confidential any code assigned by SMARTIC. AVAILABILITY OF SERVICE

The SERVICE will be operational every day of the week, 24 hours a day, 365 days a year, without requiring the reservation by the CUSMOER, except in case of maintenance, updating and/or service improvements. SMARTIC reserves the right to cancel the SERVICE if it is not accessed in for 3 months. SMARTIC can exercise this right without any responsibility and/or compensation by SMARTIC. SMARTIC provide the SERVICE free of charge, without prejudice to the cost of the phone call to 902 that both the CUSTOMER and participants of the conference must pay to the operator for access in accordance with the then current rates. Therefore, SMARTIC is under no obligation to issue invoices to the CUSTOMER for the service provided.

LIABILITY FOR USE OF THE SERVICE

The CUSTOMER is solely responsible for the content, use and disclosure of information and communications transmitted through the SERVICE, the supply and maintenance of telephone lines by the contractor and to comply with the current provisions in protection of personal data, privacy and technical specifications of equipment and telecommunications devices.
